The Hollofield Day Use Area is open year round, seven days a week. The Hollofield Campground is open late March/ April through the last weekend in October.

Park Entry Fee During BSFS Picnic: (Confirmed 06/06/2022)

The State of Maryland has a park entry fee collected by a park ranger at the park entrance:

Maryland Residents \$3.00 per person.

Out of Maryland Residents \$5.00 per person.

Admitted Free:

Children buckled in safety seats
Senior citizens 62 & older with the Golden Age Pass (requires one-time \$10 administrative fee – information available at http://www.dnr.maryland/gov/publiclands/goldenage.asp),

People with the Access Maryland State Park Pass for persons with disabilities, Members of the Maryland National Guard & all Active Duty military personnel who display their active military identification card (complimentary access is permitted for card holder only).

Entry service charges are not included in pavilion/shelter rental costs; they are additional to those costs. Those wanting to prepay the service charges need to contact the park office before the reservation date.

All Maryland State Parks are "trash-free", meaning there are no trash cans to ruin the view, or to attract flies, bees, and other wildlife. Visitors are asked to take their trash home with them when they leave.

Pets are allowed in the Hollofield area. Pets are not allowed in park buildings, restrooms, or on playgrounds and must be on a leash, under your control at all times. Pet owners must pick up after their pets. Alcoholic beverages are PROHIBITED except by permit and may ONLY be consumed in the designated shelters by persons 21 years of age or older. Permits are available through the Reservation Department and must be obtained prior to the event.

Inflatable play equipment and trampolines are prohibited on site without a permit. To obtain a permit and the required paperwork, the reservation holder needs to contact the park headquarters three (3) weeks prior to the event. Please visit the shelter to ensure the site will accommodate the size of equipment you plan on reserving, as some sites are very small. Due to the need for water conservation, any device requiring water (eg. portable swimming pools, dunk tanks, etc.) are NOT allowed in the park. To play any type of music (DJ's, radios, microphones, etc.), a permit is required. Permits need to be obtained prior to your event from the park headquarters.

Campers whose units are over 11'1" in height must call the park headquarters before arriving for special instructions.


